

CORPORATION OF THE TOWNSHIP OF HAVELOCK-BELMONT-METHEUN

BY-LAW NO. 2009 - 16

BEING A BY-LAW TO AMEND BY-LAW 2008-85, TO APPOINT PERSONS TO VARIOUS BOARDS AND COMMITTEES REPRESENTING THE CORPORATION OF THE TOWNSHIP OF HAVELOCK-BELMONT-METHUEN FOR 2009 – 2010.

WHEREAS Section 207(45) allows for municipal Councils to pass by-laws for appointing such officers and employees as may be necessary for the purposes of the corporation, or for carrying into effect any Act of the Legislature or by-law of the Council, and for fixing their remuneration and prescribing their duties, and the security to be given for the performance of them;

AND WHEREAS the Council of the Corporation of the Township of Havelock-Belmont-Methuen deems it expedient to appoint members of Council and persons from the community to various Boards and Committees;

AND WHEREAS the Council of the Corporation of the Township of Havelock-Belmont-Methuen wishes to update the appointment by-law to reflect changes to the committee structure and councillor appointments for 2009-2010;

NOW THEREFORE the Council of the Corporation of the Township of Havelock-Belmont-Methuen enacts as follows:
